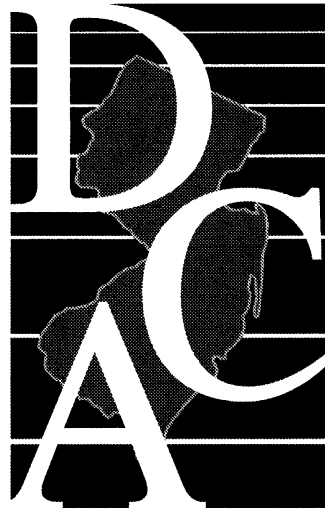

FISCAL YEAR: FROM: JUNE 1, 2014 TO: MAY 31, 2015

WHEREAS, the Annual Budget and Capital Budget for the Penns Grove Sewerage Authority for the fiscal year beginning, June 1, 2014 and ending, May 31, 2015 has been presented before the governing body of the Penns Grove Sewerage Authority at its open public meeting of March 20, 2014; and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$ 1,225,800.00 , Total Appropriations, including any Accumulated Deficit if any, of \$ 1,273,300.00 and Total Unrestricted Net Assets utilized of \$47,500.00; and

WHEREAS, the Capital Budget as introduced reflects Total Capital Appropriations of \$ -0-and Total Unrestricted Net Assets planned to be utilized as funding thereof, of \$ -0-; and

WHEREAS, the schedule of rates, fees and other charges in effect will produce sufficient revenues, together with all other anticipated revenues to satisfy all obligations to the holders of bonds of the Authority, to meet operating expenses, capital outlays, debt service requirements, and to provide for such reserves, all as may be required by law, regulation or terms of contracts and agreements; and

WHEREAS, the Capital Budget/Program, pursuant to N.J.A.C. 5:31-2, does not confer any authorization to raise or expend funds; rather it is a document to be used as part of the said Authority's planning and management objectives. Specific authorization to expend funds for the purposes described in this section of the budget, must be granted elsewhere; by bond resolution, by a project financing agreement, by resolution appropriating funds from the Renewal and Replacement Reserve or other means provided by law.

NOW, THEREFORE BE IT RESOLVED, by the governing body of the Penns Grove Sewerage Authority, at an open public meeting held on March 20, 2014 that the Annual Budget, including appended Supplemental Schedules, and the Capital Budget/Program of the Penns Grove Sewerage Authority for the fiscal year beginning, June 1, 2014 and ending, May 31, 2015 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the said Authority's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the governing body of the Penns Grove Sewerage Authority will consider the Annual Budget and Capital Budget/Program for adoption on April 17, 2014.

The Board has prepared a comprehensive budget that will be sustained by the current rate schedules. The overall budget of the Authority did not change. The Authority was able to achieve this by maintaining appropriations at the same or reduced amounts, continued participation in the State Health Benefits Plan as well as negotiating better third party provider rate for electricity. The Authority decreased the fund balance utilized by \$850.00 due to increased anticipated revenue in the form of penalties.

2. Complete a brief statement on the impact the proposed Annual Budget will have on Anticipated Revenues, especially service charges and on the general purpose/component unit financial statements. Explain significant increases or decreases, if any.

The Authority does not have plans to increase the sewer rate at this time.

The local economy has had no significant changes in the current year. The overall decline in the economy has not materially affected the Annual Budget or Capital Budget.
