Sealed proposals for Supply of Cationic Emulsion Polymer for a TWO (2) year period, to the Penns Grove Sewerage Authority will be received by the Penns Grove Sewerage Authority at the offices of the Penns Grove Sewerage Authority, 81 Beach Avenue, Penns Grove, New Jersey 08069, on December 3, 2019 at 10:15 am prevailing time, at which time and place they will be publicly opened and read out aloud.

No bids will be received unless in writing, on forms furnished, and unless accompanied by a bid guarantee made payable to the Penns Grove Sewerage Authority. The bid guarantee shall be in the amount of 10% of the total bid, but not exceed \$20,000, and shall be in the form of a certified check or bid bond, at the option of the bidder. A Consent of Surety Statement shall also accompany the bid. No bids may be withdrawn within sixty (60 days) of the receipt of bids. The Authority reserves the right to reject any or all bids, to waive any informality in any bid, and to accept the bid which, in its judgment, best serves the interest of the Authority.

Bidders are required to comply with the requirement of P.L. 1975, C12. (NJAC 17:27).

Bidding documents will be available on November 18, 2019 and may be examined and obtained from the office of the Authority, 81 Beach Avenue, Penns Grove, New Jersey 08069 upon the payment of \$75.00 (in the form of a check made out to The Penns Grove Sewerage Authority), which amount will not be refunded.
